### 2012 VA NENA Spring Conference Business Meeting May 18, 2012

Allan Weese called this meeting to order at 10:19.

#### Secretary's Report

The 2011 Fall Business Meeting Minutes are available on the website for viewing. Craig Sheets motioned to approve the minutes and it was seconded. All members were in favor. The floor was opened up for discussion and nothing was brought to the floor.

#### Treasurer's Report

We went over the treasurer's report which most of it I got last night. There is a membership rebate she talked about. Craig said a motion to accept and it was seconded. There is no discussion. We all approved.

#### **Committee Report**

Grants committee The chairperson is Allan Weese. Allan spoke about the wireless grant changing and advised membership that there were more PSAPS that signed up. In regards to the future of the grant program, he advised that there are some changes that are coming out for next year. He said the Wireless Board is voting on that for the next meeting, and in the next grant cycle, it will be discussed. The Wireless Board is concentrating on next generation and education. He suggested that PSAP's make sure that when the grant cycle comes around; everyone applies with your VITA rep, and ensures the paperwork is turned in.

<u>Conference Committee</u> The chairperson is Denice Marrs. She said that this was a successful conference. She advised the total attendees numbered 777; Dispatch track had 336, Management track had 247, Technical track had 132, and the Interoperability track had 62. This is the largest group we have had for a spring conference. She will be the conference committee chair next year. Erin Elrod reported that the "George Thomas Children's Memorial Fund" raised \$1142.00.

Bylaw Committee The chairperson is Allan Weese. He advised that this would be deferred. Changes have

been suggested and that will be covered under new business.

<u>Membership Committee</u> The chairperson is Erin Elrod. She reported that there are 162 members, 23 dispatchers and 45 ENP's. She is on the national NENA membership committee & there will be a survey coming out; she encouraged the members to please fill this out.

Election Committee The chairperson is Buster Brown. He advised that this will be deferred.

#### **Regional Director Reports**

Cheryl Buchanan is the Regional Director for Region 1; the Capital Region. Karen Smallwood is the Regional Director for Region 2; the Northern Region. Region 2 had their meeting on March 29<sup>th</sup> 2012 and it was not well attended. Karen reported that Prince William came. Derrick Ruble is the Regional Director for Region 4; the Southwestern Region. Derrick reported that their region was able to come together and network a bit. He explained that many jurisdictions in his region were experiences massive budget cuts, and that many PSAP directors are dispatching now. Many consolidations are going on, and Derrick plans on teleconferencing for his meeting. Katie Boone is the Regional Director for Region 5; the Southeastern Region. Katie advised that they held their meeting but it was not very well attended. Aleta Coleman is the Regional Director for Region 6; the Western Region. Aleta advised that their meeting was April 3<sup>rd</sup> and it wasn't well attended. She was elected in this meeting. Region 3, which is the Central Region, does not have a regional director, and the board is looking for volunteers. Allan chimed in and said not to get discouraged just because attendance has been low. He advised that as more information gets out he expects there to be more communication. He suggested the possibility of regional picnics, or ideas similar in nature that would foster communication and networking.

#### **Old Business**

Virginia NENA had an audit. It cost \$400.00 everything was in order. The auditors went back three years. The auditor referred NENA to someone in Richmond for incorporation. In 2009 the net income was -\$5201.40. In 2010 the net income was -\$2038.14. In 2011, the net income was \$435.40 in the positive. Jackie reported that the biggest expenses are the conferences. This year they bonded the treasurer's. The treasurer's report will now be included in the minutes. Membership discussed this; it was seconded and Allan accepted the motion. Allan explained that the lawyer in Richmond specializes in non-profit organizations. He also stated that applying for 501(c) could take up to three months. This will put us in a tax-deferred status.

In reference to the ENP Study Group, Buster said that he spoke to Kay Carroll and there is no plan for an ENP study group. There are 45 in the state.

A few years ago, NENA passed a motion to offer scholarships for people who take and pass the ENP exam. They allotted enough funding to be able to do four individuals a year (providing they pass). More information is available on the website. It was explained that one will have to pay up front for the test but then they will be reimbursed.

#### Elections

The 2012-2013 Virginia NENA officers are as follows; President is Erin Elrod, the 1<sup>st</sup> Vice President is Denice Marrs, The 2<sup>nd</sup> Vice President is Craig Sheets, and the Immediate Past President is Allan Weese. The Treasurer is Jackie Carroll and the Secretary is Shelia Ragan. Cheryl Buchanan is the Regional Director for Region 1, the Capital Region. Karen Smallwood is the Regional Director for Region 2, the Northern Region. Derrick Ruble is the Regional Director for Region 4, the Southwestern Region. Katie

Boone is the Regional Director for Region 5, the Southeastern Region. Aleta Coleman is the Regional Director for Region 6, the Western Region.

Carol Adams made a motion Julie McKercher seconded it. Membership did not wish to discuss this matter, and everyone voted in favor of the new officers. Buster swore everyone in.

#### Transition from old president to new president

Allan handed over the plaque to Erin as president. Erin presented a plaque to Allan. Erin gave a little bit of background about herself. In 2005, Erin became a member of NENA. In 2009, Buster approached her about becoming more involved in NENA. She advised that she had three goals as the incoming Virginia NENA's president; 1) Incorporation, 2) strengthening the professional relationship between the NENA/APCO boards, having them work more closely together, and 3) getting more people involved.

#### New business

<u>Committee Volunteers</u> Bylaws and Nominations is Allan Weese and the Conference is Denice Marrs. There is currently no one volunteering for the following committees; Commercial, Membership, and Technology.

**Bylaw changes** Article III, Section 2, Subsection 2.2, details the deletion of the requirement for officers to be an ENP. Emily Totten moved to accept this and Julie McKercher seconded it. There was no discussion by the members, and everyone was in favor. Erin Elrod said it passed.

The second change dealt with Article IV Section 2, Subsection 2.6, and involved dividing the existing regions. Region 11 is now The Valley Region. This will consist of the Counties of Clarke, Culpeper, Fauquier, Frederick, Madison, Orange, Page, Rappahannock, Rockingham, Shenandoah, Spotsylvania, Stafford, and Warren. Also included in Region 11 are the Cities of Fredericksburg, Harrisonburg, and Winchester.

The third change dealt with the same subsection and made Region VII the Northern Region, to include the Counties of Arlington, Fairfax, Loudoun, and Prince William. Region VII also will include the Cities of Alexandria, Fairfax, Falls Church, Manassas, and Manassas Park.

Allan Weese gave a motion to accept these changes. Craig Sheets asked if this separation mirrored the Virginia State Police, and Allan advised that it did. Denice Marrs seconded this motion. All membership was in favor.
